NCS FACE COVERING STATEMENT

LOCAL PROTOCOLS

- THERE ARE NO FACE COVERING OR SOCIAL DISTANCING REQUIREMENTS.
- Due to the fact that this is an outdoor meet, there are no additional local protocols
- Meet capacity will be based on the fire code of the facility.
- Number of timers 1 TIMER PER LANE Each timer will utilize a stopwatch and plunger button. Primary is automatic system with touchpads.
- Restroom facilities in the Port-a-pottys (outside of the fence) are for parents, coaches, and volunteers only. Locker room restrooms on pool deck are for swimmers only and cannot be used for changing or showering.

LOCKER ROOMS/ CHANGING

Locker rooms are for restroom use and changing into racing suits. Showers are unavailable. Deck changing is prohibited.

SPECTATOR LIMITATIONS and PROTOCOLS

Spectators/Parents are allowed at this meet. and are expected to comply with all mandated state/local/facility COVID-19 guidelines.

FACILITY

The Sportscenter of Morehead City - The Sports Center, 701 N. 35th Street, Morehead City, NC - The outdoor facility has an 8-lane 50-meter non-turbulent competition pool with 2 lanes available for continuous warm-up/warm-down. Pool depth is 4' at both ends. A Colorado 6 Automatic Timing System with touch pads will be used. There will be one timer in each lane operating both watch and a plunger. A digital scoreboard will also be in use. The competition course has been certified in accordance with 104.2.2C(4). A copy of such certification is on file with USA.

Please NOTE: Meet Management retains the right to change any and all session times (warm-up and Start times) if agreed to by a coaching representative from each invited team.

RULES

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional, and exceptions are stated.

TECHNICAL SUIT BAN for 12&Us

Per USA Swimming Rule 102.8.1F, 12 & Under athletes may not compete in Technical Suits at this meet.

A Technical Suit is one that has the following components:

- Any male or female suit with bonded or taped seams regardless of fabric or silhouette; or
- Any male or female suit with woven fabric extending to the knee or midthigh regardless of the seam type.

MAAPP

All applicable adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

SAFE SPORT

The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. Swimmers may be dropped off only in designated safe areas. Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms. No glass containers or bottles are allowed inside the facility at any time. Anyone failing to comply with a safety request may forfeit his or her privilege to participate. We strongly recommend each team assign a marshal to monitor warm-up sessions and locker rooms in addition to host team marshal.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, or behind the starting blocks. Flash photography of any kind is prohibited at the start of a race.

Deck changes are prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. It is also the responsibility of the swimmer or the swimmer's guardian to request assignment from the Meet Director to a USA Swimming member coach attending the meet if a coach from the swimmer's team is unable to attend.

Unless approved in writing in advance of the competition by the Program and Events Committee Chair or designee, operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.

Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on deck. No spectators will be allowed on deck at any time.

ELIGIBILITY

All swimmers must be registered with USA Swimming, Inc. All Adult Athletes must hold current APT certification to compete. Swimmers must be registered prior to entry deadline. Entries listed as "Registration Applied For" will not be accepted. There will be no on deck registration available at this meet.

MEMBERS WITH DISABILITIES OR MEDICAL CONDITIONS

ECA welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Members who are unable to wear face coverings because of a documented medical condition must notify the Meet Director in advance and may have limited deck access. Failure to provide advance notice may limit ECA's ability to accommodate all requests.

ENTRIES All entries must be submitted electronically.

ENTRY LIMITATIONS Swimmers may enter up to 3 events per session.

ENTRY VERIFICATION An email will be sent to the person submitting the entry confirming receipt of the

entry within 48 hours of receipt.

ENTRY DEADLINES The Meet Entry Coordinator must receive entries by the date and time listed in

the Deadline and Meeting Summary. Late entries may be accepted at the

discretion of the Meet Referee. There will be no on deck entries.

ENTRY FEES – Note ALL swimmers/coaches/parents will have access to a digital heat sheet which is included in the fees below.

SEEDING

The conforming time standard for this meet is LONG COURSE METERS. Swimmers will be seeded and swim from slowest to fastest unless otherwise indicated. All non-conforming times will be seeded last in rank order

NTs will not be accepted for any event. Coaches are asked to estimate swimmer's times who have not competed in the event LCM.

The 1500 Freestyle will be limited to the top 16 boys and top 16 girls entered. Meet management reserves the right to swim combined heats.

CHECK-IN All events will be pre-seeded except for the 1500 FR which will be positive

check-in (by 10 AM on Saturday). The Check-in process will be handled

COACHES All coaches on deck must be registered and certified with USA Swimming.

Meet Management will require all coaches to show proof of such by prominently displaying their registration card or be prepared to show their

Deck Pass virtual membership card upon request. There will be a coach/general meeting at the date and time listed in the Deadline and Meeting Summary. Other meetings may be held at the meet referee's

discretion. Meet Management requests that at least one coach representative from each team attend all coaches' meetings.

OFFICIALS/TIMERS/VOLUNTEERS

There will be a need for officials. ECA welcomes and encourages anyone willing to volunteer. Volunteering Officials **MUST**_contact the Meet Referee by email **prior to the meet.** All officials on deck must be registered and

certified with USA Swimming. Certification will be verified by Meet Referee the day before the meet / session. There will be no officials meeting at the meet, and assignments will be communicated electronically prior to each session. A virtual meeting may be held prior to the meet / session at the referee's discretion, and all assigned officials are strongly encouraged to complete and individual personal review of applicable USAS rules for their assigned position prior to the meet. Officials should report to their assigned position 10 minutes before session start, and bring a mask, your personal

water bottle, a writing utensil, and a headset (if applicable).

HOSPITALITY/
CONCESSIONS

There will be light hospitality with boxed meals for all coaches, only. There will not be concessions for this meet. Refreshments will be available in a

cooler by the computer station.

WARM-UP In accordance with USA Swimming guidelines, there will be a published

warm-up procedure for all swimmers and coaches attending the meet. The Marshall will ensure all teams, coaches, and swimmers follow all warm-up procedures. Meet Management reserves the right to change warm-up times according to the number of entries. During the competition, there will be lanes available for continuous warm-up/down (if available). **There is**

to be no diving or horseplay in this area.

WAIVER/RELEASE

As a team entered in this meet, upon entry you are verifying that all of the swimmers and coaches listed on the enclosed entry are registered with USA Swimming.
