FACILITY & HOST REQUIREMENTS

GCY has discussed specific health and safety procedures with the venue management. At this time, the facility and GCY have no additional requirements. Compliance with the most current guidelines from USA Swimming, North Carolina Swimming, CDC, State and Local jurisdictions will be maintained throughout the duration of the meet.

FACILITY

The Greensboro Aquatic Center is a state-of-the-art indoor facility with four pools. The main competition pool is 9-10 feet deep at both ends and will be configured into one 50-meter course with eight 9-foot wide lanes each. All lanes feature non-turbulent lane lines and KDI Paragon starting blocks with Omega track-start tops. Up to eight lanes will be used for this competition. The Omega electronic timing system will be used which includes touch pads and 2 buttons per lane. In addition at least one manual stopwatch will be used in each lane. Prior to each session of competition, the facility host shall examine the bulkhead and shall confirm to the Meet Referee that the bulkhead is stable, straight and properly positioned and anchored.

Lifeguards and GAC staff will provide medical support.

Seating for 1800 spectators is available.

Parking will be available for up to \$5.00 per vehicle. Free parking passes will be provided for volunteers, coaches and officials.

All spectators must comply with the Greensboro Coliseum Complex Bag Policy:

Permitted Bags

- **Clear Bags:** Clear vinyl or plastic bags, one-gallon Ziploc-style storage bags, and clear vinyl or plastic backpacks, measuring no larger than 12" x 6" x 12".
- **Small Clutch Bags:** Small bags up to 4.5" x 6.5" (*approximately the size of a hand*), with or without a handle or strap, do not have to be clear.
- **Medical Bags:** Medical bags, including diaper bags when accompanied by a child, will be inspected before entry.

Greensboro Coliseum Complex personnel reserve the right to deny entry to any bag or item that is deemed unsafe for admission. Guests who do not follow building policies or decline to be inspected may be denied entry or required to leave the venue. Greensboro Coliseum Complex does not provide a bag check or lockers for bags. All bags left in lobbies/hallways will be discarded.

No outside food or drink is permitted in the facility. No coolers are allowed in the facility.

No outside chairs are allowed on deck or in the stands.

MEET FORMAT

Competition for 13 & over events shall consist of preliminaries and finals, except as otherwise noted. All 12 and under competition will be timed final events.

RULES

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated.

- All events will be pre-seeded with the exception of the 400-meter freestyle, the 800-meter freestyle, the 1500-meter freestyle and the 400-meter individual medley. A positive check-in will be required for each of these events.

- The 1500-meter freestyle will be swum fastest to slowest, alternating women and men.
- The referee and meet management reserve the right to combine heats and/or events as well as restrict the number of heats to adhere to the timeline.
- Deck entries (only to fill empty lanes) will be taken until 30 minutes prior to the start of the session.

TECHNICAL SUIT BAN for 12&Us

Per USA Swimming Rules, 12 & Under athletes may not compete in Technical Suits at this meet.

A Technical Suit is one that has the following components:

- Any male or female suit with bonded or taped seams regardless of fabric or silhouette; or
- Any male or female suit with woven fabric extending to the knee or mid-thigh regardless of the seam type.

MAAPP

All adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.

SAFE SPORT

The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. Swimmers may be dropped off only in designated safe areas. Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms. No glass containers or bottles are allowed inside the facility at any time. Anyone failing to comply with a safety request may forfeit his or her privilege to participate. We strongly recommend each team assign a marshal to monitor warm-up sessions and locker rooms in addition to host team marshals.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, or behind the starting blocks. Flash photography of any kind is prohibited at the start of a race.

Deck changes are prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. It is also the responsibility of the swimmer or the swimmer's guardian to request assignment from the Meet Director to a USA Swimming member coach attending the meet if a coach from the swimmer's team is unable to attend.

Unless approved in writing in advance of the competition by the Program and Events Committee Chair or designee, operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.

Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on deck. No spectators will be allowed on deck at any time.

ELIGIBILITY

- All swimmers must be registered with USA Swimming, Inc. Swimmers must be registered prior to entry deadline. Entries listed as "Registration Applied For" will not be accepted. There will be no on-deck registration available at this meet.
- All adult athletes must hold current APT certification to compete.
- No qualifying times are required.

AGE GROUP

Swimmers ages will be determined as of the first day of the meet (June 13, 2025). The age groups for competition will be as follows: 10 & Under, 11-12, 13-14 and 15 & Over. 10 & Under and 11-12 events will be swum together and awarded separately. During preliminaries and all timed final 13 & Over events, 13-14 and 15 & Over events will be swum together.

MEMBERS WITH DISABILITIES OR MEDICAL CONDITIONS

GCY welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit GCY's ability to accommodate all requests.

ENTRIES

Entries submitted in Hy-Tek format require no hard copy entry forms. Email is preferred for electronic entries. A completed and signed Entry Summary Sheet (included in the announcement) and payment in full must be received by the Meet Entry Coordinator by the first day of the meet for entries to be considered complete. Entries will be entered in the order received. All relay-only swimmers, including alternates, must be listed and pay the Travel Fund and Facility Surcharge. Rejected entries will be returned immediately. Unless entries are rejected, entry fees are non-refundable. The conforming time for this meet is LCM. Entries should be made with LCM times, converted SCY times, or estimated LCM times. NT will be seeded last.

ENTRY LIMITATIONS

- All swimmers participating in any 13 & Over prelim/final event may swim a maximum of 3 individual events and 1 relay per day and a total of 8 individual events and 2 relays for the meet.
- 12 & Under swimmers participating in timed final events only may swim a maximum of 4 individual events and 1 relay per day and 10 individual events and 2 relays for the meet.

ENTRY VERIFICATION

An email will be sent to the person submitting the entry confirming receipt of the entry within 48 hours of receipt.

ENTRY DEADLINES

The Meet Entry Coordinator must receive entries by midnight on Tuesday, June 3, 2025. Late entries may be accepted at the discretion of the Meet Referee.

SEEDING

The conforming time standard for this meet is long course meters. Entries should be made with LCM times, converted SCY times or estimated LCM times. Swimmers will be seeded and swim from slowest to fastest unless otherwise noted. All non-conforming times will be seeded last in rank order.

All 12 & Under competition will be timed finals.

All events 200 meters and below will be pre-seeded.

All individual 13 & Over events except those 400 meters (see below) and over will be contested as preliminaries/finals. The finals session will include A and B heats for all 13-14 events; and A, B and C heats for all 15 & Over events. All finals events will be swum slowest to fastest. There will not be a Ready Room. All heats should report to the blocks.

The 13 & Over 400-meter Freestyle and the 400-meter Individual Medley will be swum as timed final events and will be seeded after positive check in. The fastest 2 heats of positively checked in swimmers in each event will swim with finals, slowest to fastest in event order. Remaining heats will swim at the end of preliminaries, fastest to slowest. The events may be limited to the 5 fastest heats (3 preliminary and 2 final) of positively checked in swimmers. No AM/PM option will be offered. Swimmers must provide their own timers during prelims. All swimmers will swim together and be separated by 13-14 and 15 & Over age groups for results.

The 13 & Over 800-meter Freestyle events will be swum as timed final events and will be seeded after positive check in. An AM/PM option will be offered for these events. The fastest heat of positively checked in swimmers selecting the PM option in each event will swim with finals in event order. Remaining heats will swim at the end of preliminaries, fastest to slowest in event order. The events may be limited to the 3 fastest heats (2 preliminary and 1 final) of positively checked in swimmers. Swimmers must provide their own timers and counters during prelims and counters during finals. All age groups will swim together and be separated by 13-14 and 15 & Over age groups for results.

CHECK-IN

A positive check-in, located in Clerk of Course, will be required for the following events:

- 13 & Over 400-meter Individual Medley
- 13 & Over 1500-meter Freestyle
- 13 & Over 400-meter Freestyle
- 12 & Under 400-meter Freestyle
- 13 & Over 800-meter Freestyle

Check-in for the events above will close 30 minutes prior to the start of the session.

SCRATCHES	<p>There will be no penalty for scratching or failing to compete in pre-seeded events at the block.</p> <p>For deck-seeded events, swimmers who are properly checked in and seeded but fail to compete and are not excused by the Meet Referee will be barred from their next individual events.</p> <p>Swimmers who are named in the original qualifying heats for finals, who do not scratch, and then fail to compete will be barred from their next individual event, unless excused by the Meet Referee.</p>
SCORING	This meet will not be scored.
AWARDS	Ribbons will be awarded to the top 8 finishers for 10 & under and 11-12 individual events and top 3 finishers for 12 & under relays. No ribbons will be awarded for 13 & Over events.
RESULTS	Results will be sent to each team via email attachment and posted on the NC Swimming web-site.
COACHES	<p>All coaches on deck must be registered and certified with USA Swimming. Meet Management will require all coaches to show proof of certification and registration. Coaches shall prominently display their registration cards at all times while on deck.</p> <p>There will be a coaches' meeting via Zoom prior to the meet. Other meetings may be held at the meet referee's discretion. Meet Management requests that at least one coach representative from each team attend all meetings.</p>
OFFICIALS	<p>There will be a need for officials. GCY welcomes and encourages anyone willing to volunteer. Volunteering officials are asked to contact the Meet Referee by email prior to the meet. All officials on deck must be registered and certified by USA Swimming. Certification will be verified by Meet Referee. Please be prepared to display your virtual membership card. Meetings will be in-person 45 minutes prior to the start of each session.</p>
TIMERS/ VOLUNTEERS	GCY welcomes volunteer timers and marshals from visiting teams. Please check in with the volunteer coordinator at the entrance to get an assignment and deck pass. Timers' and marshals' briefings will be held approximately 30 minutes prior to the start of each session.
HOSPITALITY/ CONCESSIONS	There will be a hospitality area open to all coaches and officials. On-deck hospitality may be available for timers and other volunteers. Refreshments for spectators will be available at the concession stand in the concourse.
WARM-UP	Specific warm-ups will be held in accordance with the NCS safety program. Specific warm-up times, procedures and lane assignments for warm-ups will be e-mailed to the contact coach and be posted on deck. Please begin all warm-up procedures at the starting end of the pool only. Feet-first entry is required until specific warm-up period is announced. Meet Marshals will ensure all teams, coaches and swimmers follow all warm-up procedures. During the competition, there will be lanes available for continuous warm-up/down. There is to be no diving or horseplay in this area.
