FACILITY

The Greensboro Aquatic Center is a state-of-the-art indoor facility with three pools which opened in August 2011. The main competition pool is 9-10 feet deep at both ends and will be configured into one 50 meter yard courses with up to eight 9-foot wide lanes each. All lanes feature non-turbulent lane lines and Colorado starting blocks. Up to eight lanes will be used for this competition. If entries warrant, additional competition lanes may be utilized. The Colorado electronic timing system will be used. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. At least three lanes will be open for continuous warm up and down. Seating for 1800 spectators is available. The Greensboro Coliseum will provide free parking. Directions to the GAC are available at www.GSAswim.org.

This is a time trial pre-seeded/deck seeded meet.

RULES

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated.

ELIGIBILITY

This meet is intended for swimmers attempting to secure qualifying times for 2014 Summer Junior and Senior Long Course Championships. The meet is open to all properly entered 2013 Winter Junior Nationals swimmers including relay only swimmers. Other USA Swimming registered swimmers may enter provided they have attained Senior Sectional cuts (as listed in the Order of Events) in the events in which they wish to time trial. All swimmers must be registered with USA Swimming, Inc. Swimmers entering on deck who are not entered in the Winter Juniors meet must provide proof of USA Swimming membership as well as proof of qualifying time. No on deck registration is available.

ENTRIES

Entries may be submitted via OME up until 11:59 PM on Friday, December 13. Entries will also be accepted at the Time Trial area on deck during regular time trial sign up hours during preliminary sessions on Thursday and Friday.

A completed and signed Entry Summary Sheet (included in the announcement) and payment in full must be received by the Meet Entry Coordinator by the entry deadline for OME entries to be considered complete. On time deck entries will be considered complete with cash/check payment at time of entry.

OME entries and on deck entries received by the 11:59 PM Friday, December 13 deadline will be seeded first. On deck entries received after that point will be accepted on a first come, first served basis pending lane availability or at the discretion of the Meet Referee.

Entries should be made with LCM or SCY times. Swimmers properly entered in the 2013 Winter Juniors meet may use override times in OME. Other swimmers may only enter with provable times except with permission of the Meet Referee.

GSA reserves the right to limit entries in order to comply with the four hour rule. Rejected entries will be returned immediately. Unless entries are rejected, entry fees are non-refundable.

ENTRY LIMITATIONS

Swimmers may swim a maximum of two (2) time trials. Swimmers may enter either the 800M Freestyle or the 1500M Freestyle.

ENTRY VERIFICATION

A preliminary heat sheet will be posted on Saturday, December 14 at the GAC and on www.GSAswim.org.

ENTRY DEADLINES

OME and on time deck entries will close on Friday, December 13, 2013 at 11:59 PM. Late on deck entries will be accepted at the Time Trial table at the GAC during regular time trial sign up hours on Saturday and until 9:00AM on Sunday if empty lanes are available or at the discretion of the Meet Referee. GSA reserves the right to limit or suspend the addition of swimmers or heats to accommodate late on deck entries.

SEEDING

The conforming time standard for this meet is long course meters. Swimmers will be seeded slowest to fastest, LCM then SCY. GSA reserves the right to combine heats and events at the discretion of the Meet Referee.

WARM-UP

General warm up in all lanes from 7:30-8:40. Specific warm ups from 8:40-8:55 as follows: one-way dive starts in Lanes 2 and 7, pace in Lanes 1 and 8, general warm up in other lanes. The Marshall will ensure teams, coaches, and swimmers follow all warm-up procedures. Meet Management reserves the right to change warm-up times according to the number of entries. During the competition, there will be at least three lanes available for continuous warm-up/down. Swimmers will enter the pool feet first in this area.

SAFE SPORT

The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. Swimmers may be dropped off only in designated safe areas. Swimmers are not permitted in work out rooms, storage rooms, meeting rooms, or control rooms. No glass containers or bottles are allowed inside the facility at any time. Anyone failing to comply with a safety request may forfeit his or her privilege to participate. We strongly recommend each team assign a marshal to monitor warm-up sessions in addition to host team marshal.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

Only swimmers, properly certified officials and coaches, and meet volunteers will be allowed on deck. No spectators will be allowed on deck at any time.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

SCORING/AWARDS

This session will not be scored and no awards will be made.

RESULTS

Results will be posted on GSA's website (<u>www.GSAswim.org</u>) within 24 hours of the meet's conclusion and teams will be emailed their results.

SWIMMERS WITH DISABILITIES

GSA welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal

assistants required and/or registered service animals. Failure to provide advance notice may limit GSA's ability to accommodate all requests.

COACHES

All coaches on deck must be registered and certified with USA Swimming and must check in with the Meet Director. Meet Management will require all coaches to show proof of certification/registration and coaches shall prominently display their registration cards at all times while on deck.

There may be a General Meeting Sunday morning at 7:15 at the Meet Referee's discretion. Other meetings may be held at the Meet Referee's discretion. Meet Management requests that at least one coach representative from each team attend all coaches' meetings. Coaches are responsible for any information presented at the meeting.

OFFICIALS

GSA welcomes and encourages certified officials to contact the Meet Referee by email prior to the meet. All officials on deck must be registered and certified with USA Swimming and will be required to show proof of current certification/registration. Officials shall prominently display their registration cards at all times while on deck. Official briefings will be held 45 minutes prior to the start of the session in the hospitality area.

TIMERS

GSA welcomes volunteer timers from visiting teams. Please check in with the volunteer coordinator at the entrance to see if there are open lanes and to get a deck pass. Timers meetings will be held approximately 20 minutes prior to the start of the session.

HOSPITALITY/ CONCESSIONS

There will be limited hospitality available on deck to all coaches and officials. Refreshments will be for sale at concession stands. Outside food beyond that needed for swimmer nutrition and hydration is not permitted by the facility.
