2009 Spring House of Delegates General Chair Report

At the USAS convention this past fall, USA Swimming unveiled the LSC Evaluation and Achievement Program (LEAP). The program is similar to the Club Recognition Program, but is aimed at LSCs. This program is a guide for LSCs to determine where to expend their resources to provide the necessary services to their members. North Carolina volunteered to be one of the test LSCs to evaluate the program.

In January of this year, the Board along with other invited members held a planning retreat to evaluate North Carolina's compliance. Although small in number, the group did an in depth evaluation of the LSC. The group determined that North Carolina was in met most of the requirements for level 1 and 2. A number of items would have to be completed, but they were not very involved and would not require much funding. The board voted to pursue level 1 by the 2009 Fall HOD meeting. After beginning the LEAP test program in March, it appears that we should be able to achieve this goal within the next several months.

Several of the new items put in place as a result of the LEAP program:

- Establishing an Outreach program
- Filling of key committees
- Posting Board Members, Committees and Committee Members on the website
- Posting BOD and HOD minutes on the website
- Approving a Conflict of Interest Statement for BOD and Committee Members
- Naming 2 additional Athlete Reps to the BOD

Level 2, while not expensive, will require developing documents and the creation of programs/procedures. My goal is to complete all the requirements for Level 2 by the 2009 Fall House of Delegates.

Level 3 contains a number of requirements that would be beneficial, but it would also require some extensive changes that could require significant funding. Pursuit of Level 3 will be a discussion for future Board Meetings and retreats.

The need for volunteers was the area identified during our retreat as our biggest challenge. We not only need volunteers to run meets, we need volunteers to run our LSC. Most of the work in the LSC is done by about 15 people. To survive and grow, we need more people to be involved. There are plenty of opening on committees to get everyone involved. Parents aren't our only source of volunteers; coaches are needed to help on committees and the Board.

Meet Schedule-

- 1) More information than in years past. Thank you to all teams for supplying information on YMCA, Inter squad, dual, tri, and quad meets.
- 2) GSC and NOMAD both bid for meets on Fall HOD. This is a protected weekend and both will have to move in order to receive a sanction.
- 3) Qualifiers- Discussion on how many the LSC needed. No action taken at this time.
- 4) Fall HoD- site to be solicited by General Chair for fall 2009. Both High Point and YOTA offered space.
- 5) Y State and Region dates- March 5-7 and 19-21, 2010.
- 6) Time Standards
 - a. Senior Champs Committee approved 4% of ESSZ Senior Sectional Time to be or QT for Senior Champs. John Roy- Would like to see any standard that gets slower to stay as it is, all others to go to 4%.
 - b. Age Group Tabled and sent back to Age Group Committee for direction. Our current system of 48th place 200's and longer and 56th place 100's and shorter is broken. Chair argued that a system needs to be in place that allows for at least those numbers annually.

There were three proposition placed before the committee;

- 1) Move all events except the 200 IM and add the 500 free to Friday afternoon. All other events go to Saturday or Sunday. Saturday 2h 16m (194 500) Sunday 2h 39m (191 508). Swimmers are allowed to enter a max of 9 events for the meet. (You have to do this so one age group does not have the ability to score more points than another.)
- 2) Take all the standards to the following formula based on Age Group Sectionals
 - a. 10U 6% 11-12 4% 13-14 2%
- 3) Allow Bonus swims as follows
 - a. 10U 1cut 1bonus, 2cuts 2bonus, 3cuts 3 bonus (10U get more bonus as we are trying to build the population of the meet)
 - b. 11-12 2cuts 1bonus, 3cuts 2bonus
 - c. 13-14 3cuts 1bouns, 4cuts 2bonus

Safety Coordinator 2008 Year End Accident Report

NCS reported 24 incidents to US Swimming for the 2008 calendar year. With reported national accidents totaling 1,008, NCS was responsible for only 2.38% of all reported incidents. NCS was responsible for 2.47% of the nationally reported incidents for the 2007 calendar year.


USA Swimming received a total of 21 of the reported 24 incidents that occurred during the 2008 calendar year. The NCS Safety Chair received only 11 incident reports of the total number reported. I would like to respectfully request that more careful attention be spent to sending a copy to both USA Swimming and to the NCS Safety Chairman. Sending copies to both parties allows a more accurate account of incident occurrence, allows for better checks and balances between USA Swimming and NCS, and reduces liability issues for both USA Swimming and NCS.

2009 Spring House of Delegates Sanction Committee Report

Since the Fall House of Delegates, the sanction committee has reviewed meet information from 72 meets with an average review period of 6 days. As shown below, since the implementation of penalties in 2008, meet information on average has been submitted 35-50 days earlier and late submittals have dropped from 41.3% to less than 15% for the last short course season. To date, no late submittals have been made for the 2009 LC season. To help minimize late submittals, the committee is trying to send a courtesy email to the team contact 6-10 days prior to the submittal deadline.



The Sanction Committee in cooperation with the Official's Committee is using the sanction database to track participation in the Official's Tracking System (OTS). Meets are entered into OTS when the meet is sanctioned. The database is then utilized to ensure that officials and their participation are entered into the system for completed meets.

Official's Chair Report

Currently we have 290 certified officials. Of that, we have 42 referees and approximately 40 starters. 84 people have either started or finished up the apprenticeship as stroke and turn since September 2008.

We currently have six referee apprentices that are either finishing in long course or who have just been certified during short course.

The officials committee has come up with new guidelines for all advancement positions over the past six months.. They are posted to the website.

The board has authorized the purchase of name tags for all officials. We are in the process of finalizing this with the vendor.

NC Swimming will also provide every new referee with a whistle and each new starter with a bell.

We have implemented dedicated meet and admin referees for all state championships.

Our LSC is among the national leaders with national qualifying meets and certification levels above the LSC level. This is a continued focus during the remainder of this year. We currently have 33 officials that are qualified at the highest level for at least one position.

We will be releasing a brand new part of the web site that shows when clinics for new officials are being held around the state. This will help promote new officials joining the ranks. It will be active by 4/22/09.

NCS Open Water Report



2009 NCS OPEN WATER CHAMPIONSHPS

400M Splash and dash

Added to create more interest and hopefully to draw swimmers that might shy away from longer open water. It will be a great way for new/younger swimmers to sample open water and to start the Open Water Championship weekend. The race is a straight swim down the length of the dam which is ideal for spectators.

- This year we will add Men's & Women's Open 400M that will be scored with the idea to see how this year goes and how we can improve it for next year.
- In 2010 we are planning to add 400M for 13/14 and 11/12 as a selection race. Selection could come from Winter Age Group 14&U Championships; top 15 from the 500 receive invitation to swim.

DISCONTINUING 10K

The 10K is dropped this year for the following reasons:

- In two years of running this event, the numbers of USA Swimmers has not generated the interest we would like to see and the number of 10K age group competitors has declined.
- 2008 was about 80% Master Swimmers.

WHERE TO GO IN OPEN WATER

Although it would helpful to have some direction, there has not been much word from USA Swimming about Age Group Open Water. I have spoken to Dave Thomas from time to time about what National would like to see at the age group level but it seem that National is still concerned mostly with the elite level swimmers at this time.

Here are the main points I think will help us keep North Carolina Swimming at the forefront of US Age Group Open Water Swimming

Build the Base by increasing local participation. At present NCS runs the 3rd largest championship in the U.S. (California's La Jolla is far ahead of all others. We are slightly behind Ohio). We will keep looking for new and innovative ways, such as the 400M Splash & Dash this year, to entice new swimmers to get into Open Water swimming and compete in the NCS Open Water Championships.

- Remain one of the premiere Southern Zone Open Water teams. NCS Zone staffs in recent years have done a very good job of promoting and making open water a key part of the zone competition/experience. Competition participation is almost 100%. 2009 Zone Open Water is at Sea World Orlando!
- One of the reasons for **NCS Select Camp** is preparing swimmers for Zones and higher level competition. Hopefully we include mention of both Zone and National Open Water competition, Chip Peterson, etc.
- Establish an annual NCS Open Water Camp. Here are the points that need to be addressed to have it happen:
 - 1. Pick coaches at spring HOD to run camp in fall OR Pick in fall to run in spring
 - 2. Run camp in Pinehurst for the first 3 years due to the access to many different bodies of water in a small area. I have done a lot of the leg work already and I could be close by to help coaches when needed.
- Encourage & Assist NCS Swimmers to compete in the USA Swimming National Open Water Championships. NC swimmers scored in the top 10 over the past 5 years in Men's and Women's!
- Recognize & Support our national level open water swimmers as we do our pool swimmers
- Ask our representatives at the national levels to push for more guidance on and recognition from USA Swimming for Age Group Open Water Swimming. For example, guidance: formats and calendar of all LSC Open Water Championships and recognition: USA Swimming Web Page LSC Open Water Championships pictures/videos.

Spectator Task Force Report

The spectator fee task force was charged by the NCS Board to study the feasibility of allowing spectator fees at NCS sanctioned/approved meets. The task force looked at a number of different aspects of this proposal to come to an informed and unbiased recommendation in the best interest of the entire LSC.

It is the recommendation of the task force that NCS not allow the implementation of spectator fees at LSC meets at this time.

The following points were carefully considered in formulating our recommendation:

- <u>Legality</u> The HOD has the authority to regulate this fee which was addressed in the June BOD conference call by Peter Carney.
- <u>Comparison with other LSC practices</u> Sixteen different LSC representatives were contacted to discuss practices involving spectator fees. A summary of the findings is:
 - About 1/3 of the LSC representatives polled confirmed that it is a common practice to allow spectator fees, typically with input from the local HOD or BOD.
 - Indiana practice was the norm allowing each club or facility to charge as they desire with the market dictating the success.
 - Most LSC that have spectator fees made it a part of the bidding process and required it published in the meet information.
 - Florida Swimming tried to implement spectator fees but discontinued the practice when faced with parent opposition.
- Financial impact of additional fees:
 - When considering the financial impact on the families attending a meet, it was acknowledged that a spectator fee (although a small percentage increase in the cost of a swimming weekend) would possibly have a negative impact and alienate a significant part of our swimming community.
 - The financial impact on the facility would be marginal. Michael Curran of TAC suggested that spectator fees would not be an economical way to raise needed revenue because of the cost involved (paying staff to collect fees, cost of processing payments, etc.)

- (c) Additional Athlete Representatives, as authorized in the By Laws or required to maintain the appropriate levels of athlete representation on the Board of Directors, shall be elected for a one year term by the athletes present at the Fall House of Delegates meeting. Any athlete present who is eligible (under (a) and (b) above) to stand for election or vote may run and/or vote during this election.

ARTICLE 211: NCS ALL STAR CRITERIA AGE GROUP RECOGNITION

211.1. GENERAL Selection Recognition of NCS All Stars athletes shall be based upon times achieved by NCS registered swimmers during each season, Long Course and Short Course, September 1 to August 31, in USA Swimming sanctioned, approved, or observed meets, in the age group events designated by NCS, provided such events are offered in NCS meets and are available to all NCS swimmers.

211.2. ALL STAR CRITERA RECOGNITION

.1.2 Each NCS swimmer who individually achieves at least one USA Swimming Top 16 10 National Reportable Time is a NCS All Star.

302.2. FEES FOR LATE ENTRIES The fees charged for late entries are limited to no more than double the above listed amount for each event of that type.

302.3. Flat Fee – In lieu of a facility fee, travel fee and event fees, a club hosting a closed sanctioned meet may charge a flat fee of up to \$12 for a one day meet or \$20 for a two day meet.

302.4. TRAVEL FUND SURCHARGE The current NCS travel fund surcharge is \$2.00 per swimmer per meet. This NCS-mandated surcharge must be collected for all sanctioned NCS meets that charge or collect entry fees, except as otherwise provided in these Rules. National Championship, closed league, and open water meets are not required to collect any NCS travel fund surcharge. Refer to NCS Rules Part II, Article 209.

302.5. NON-NCS REGISTERED ENTRANTS Meet hosts may charge non-NCS registered entrants an additional fifty cents (\$.50) per individual entry and an additional one dollar (\$1.00) per relay.

302.6. FEES FOR DUAL MEETS The NCS maximum fees mandated in 302.1.1-3 shall not be imposed on any Dual Meet, regardless of the meet format, so long as the sanction application for the meet requires agreement as to the entry fees to be charged for the meet from both teams participating in the meet. Meet entry fees may be set at the discretion of the meet host.

302.7. FEES FOR LEAGUE MEETS The NCS maximum fees mandated in 302.1.1-3 shall not be imposed on any League Meet. Meet entry fees may be set at the discretion of the meet host.

302.8. FEES FOR INVITATIONAL MEETS The NCS maximum fees mandated in 302.1.1-3 shall not be imposed on any Invitational Meet, regardless of the meet format, so long as the sanction application for the meet indicates the entry fees applicable to attending teams.

302.9. NON-NCS-Championship Meet ENTRY FEES The NCS maximum fees mandated in 302.1.1-3 (or 302.1.1 if only one left) shall not be imposed on any meet which is not a NCS-Championship Meet, regardless of the meet's format. Entry fees may be set at the discretion of the meet host.

302.10. NON-NCS REGISTERED ENTRANTS Entry fees for Non-NCS Registered Entrants in meets hosted by NCS members may be set at the discretion of the NCS meet host and are not subject to the maximum fees outlined in 302.1.1-3.

302.11 FEES FOR QUAD MEETS The NCS maximum fees mandated in 302.1.1-3 shall not be imposed on any Quad-Meet, regardless of the meet format, so long as the sanction application for the meet requires agreement as to the entry fees to be charged for the meet from all four teams participating in the meet. Meet entry fees may be set at the discretion of the meet host.

302.12. FEES FOR TRI-MEETS The NCS maximum fees mandated in 302.1.1-3 shall not be imposed on any Tri-Meet, regardless of the meet format, so long as the sanction application for the meet requires agreement as to the entry fees to be charged for the meet from all three teams participating in the meet.
