- 3. Reading, correction and adoption of minutes –Lisa Olack
  - MOTION: Approve April 23, 2017, minutes PASSED
- 4. Officer Reports
  - a) General Chair Dave Olack
    - i) Any memorials to be presented at convention please forward information to Dave and Bill
    - ii) Please keep reviewing the schedule for convention on the website. All those attending are to provide a trip report especially of information that would be useful to NCS.
  - b) Treasurer Jon Fox
    - Balance Sheet and Income Statement presented as attached; there is approximately \$10K in Meet Entry Fees which needs to be transferred to Travel Fund; we will be over budget in a few areas but income is strong to cover those overages

    - i) Registered members 11,042 with 9,809 athletes, 501 coaches, 523 officials; 83 clubs
    - ii) There are 4 clubs whose head coaches are not up to date on their certifications: Kick Start, Morganton, New Millennium, PAC
  - b) Technical Planning Kevin Thornton
    - i) ACTION ITEM: Legislation for new bidding process to be presented for Fall HOD-on track-NO REPORT

- i) ACTION ITEM: Language in policy manual to include a call back number when requesting payment; to put together a procedure for payment requests; will need to be approved
  - (1) Carl recommends: All requests for funds (payment of invoices, down payments, etc.) are to be received only from individuals who are authorized to make such requests. Funds for payment should be based on approved NC LSC budgeted line items or as approved by the NCS Board of Directors. All requests for funds received by the NC LSC Treasurer by phone call or email should be followed up as soon as possible, by a call-back verification confirming the requester's identity and authorization to request the funds for payment. Any requests for funds should include a short description as to why the funds are needed and a call-back telephone number that the Treasurer can easily reach the requester at.
- ii) ACTION ITEM: Look into an ACH module and discuss with Jon Fox over concern in getting payments to vendors; receiving late notices COMPLETE
  - (1) Not in favor of setting up ACH since we usually have multiples payments to different vendors as opposed to multiple payments to a single vendor; Bank of America not very responsive with assistance in this
- iii) ACTION ITEM: Registration cards in budget for 2018; approximately \$300 COMPLETE
