General Chair

Thank you to our hosts TAC Titans and SwimMac Carolina for hosting the NCS Senior and Age Group Champ meets this year. Reports from both locations were that the meets ran smoothly overall. I received a few e-mails from parents with complaints about the crowded conditions at AG Champs which was expected. I responded to them requesting that they call me to discuss their concerns but none did.

NCS will again sponsor two tables at the NCS Hall of Fame Induction Ceremony on April 14th at the Embassy Suites in Cary. Any BOD member interested in attending should e-mail Bill Martin and myself.

NCS will be sending four members to the Leadership Summit in Houston, Tx, April 20th thru 22nd. Athletes Emile Charles and Matthew Rigsbee, and coaches Amy Faulk and Cameron Brewer will be attending.

A big Thank You to the Governance Committee for leading us through the NCS Retreat in January and driving the new BOD meeting format utilizing the consent agenda and the LSC dashboard. This change will be a little uncomfortable at first but will ultimately help us remain focused on the strategic goals of the board without sacrificing any oversight of the operational functions.

Plans and a schedule for the NCS sponsored water safety clinics are still developing, although very slowly, and my goal is to finalize things prior to the Spring HOD. I'm also working with JP Merchant on a Safe Sport Program for the month of May and you'll see the details of that under New Business.

ARTICLE 602 - MEMBERSHIP

602.1 MEMBERS - The membership of NCS shall consist of the following:

D. Flex Members - Athlete members who register with an LSC and USA Swimming are eligible for sanctioned swimming competition. Flex members are eligible to compete in only two sanctioned competitions per registration year. Flex members may not compete at or above the LSC Championship level. An athlete member shall not be registered in more than one LSC simultaneously. Flex members who transition to the Annual athlete membership category within the same calendar year will be able to credit the Flex athlete membership cost to the Annual athlete membership cost (effective 9/1/2018).

North Carolina Swimming Safe Sport Training Incentive Program

Purpose

The program is designed to increase athlete awareness of USA Swimming's on-line video - Safe Sport Training for Athletes. May 2018 is North Carolina Swimming's Safe Sport Training Month. North Carolina Swimming will track and incentivize each participating team's athlete, ages 13 to 18, that completes the online USA Swimming Safe Sport training.

<u>Results</u>

Program participation will be monitored via the SWIMS database and only "completed" training sessions will be counted.

Budget

The program budget is \$5,000

Program Period

May 1st through May 31st, 2018

Promotion

An announcement of the incentive program will be posted on the NCS website which will include a link to the training. Also, an email will be sent to all club contacts, club athlete representative and coaches. A scoreboard will be added to the NCS website to track participation during the month.

<u>Awards</u>

The incentive awards will be as follows:

- Club has 25% of its 13 to 18 year old athletes complete the training \$100
- Club has 50% of its 13 to 18 year old athletes complete the training \$250
- Club has 75% of its 13 to 18 year old athletes complete the training \$500
