Business Meeting

- NCS has lost a good friend in Kathy McKee. NCS contributed to the memorial and celebration of life for Kathy. The board reviewed additional ways to honor Kathy; recommending to name the Coach of the Year award to the 'Kathy McKee Age Group Coach of the Year Award'.
- October is the board election, and every board position is up for election. A ballot needs to be built for the elections; two individuals need to be named for each position. There will be a task force established to help identify individuals that may be interested in getting involved. Ballot must be published 20 days before the election.
- Legislative update: 1) Legislation proposed by the LSC for NCS need to be forwarded to Lisa Olack by August 12th to be presented at HOD. Anything received after August 12th requires a 90% vote. The committee will review everything on August 27th, publish proposals on September 10th, and have a proposal review meeting on September 30th at HOD
2) USA Swimming Legislation – US Swimming recently sent out the packet that will be presented at the annual business meeting in Colorado Springs in September. NCS Delegates to the meeting are Jon Jolly, Trish Martin, Steve Romito, and Jonathan Watson; representing the Rules committee is Suzanne Heath and representing CAC is Jamie Bloom. Legislation: R-9 – Proposers wanted to limit LSC's from adding additional requirements for members to

become officials, or officials to move forward/elevated to the next position. CAC has been involved this issue as well. CAC recommended to look at wording is the minimum standard for officials.

- Safe Sort – High Point got recertified.
- DEI – New DEI in SC. Plan to run the DEI camp along with Carolina Crown next year in SC. Plan to put together an 'ask' clubs "What are you doing for DEI? Plan to kick off in the fall."
