- Two pieces of legislation; R-01 removing the SSRP requirement to host meets except for LSC championship meets; R-02 establishing a new membership category, Junior Official which will require 90% for passing
- Officials Committee Update Rob Stevens
 - AG & Senior Short Course Championships will be held in February
 - AG & Senior Sectional meets will be held in NC in March
 - Committee approved the offering of the Junior Official; Policies will be updated; legislation for new category
 - Initiative for recruiting & retention is underway
 - October 1, USA Swimming's AO and Starter training will be available with NCS only conducting Referee & CJ training until those are available
